  - A. Principal 186.98; 181 enrolled; hired a math teacher but the student recruiter has transitioned out. Talked about the potential new hybrid model. Because of state testing hiatus there was a state wide postponement of the charter process. We are hoping to go through it still next year in order to implement a new hybrid cohort model. Moving from a classroom based funding model to a non-classroom based funding model through the state. But students would have the flexibility to be on site fewer days of the week and fewer hours. Independent studies has a large waitlist and we think this model would be appealing to many of them. Making this switch requires either a material revision to the charter or it can be built into the charter renewal process. We are working with ESUHSD to work out the best process. November 14 is the East Side compliance visit.
